



## ChemUse Card (AQF 3)

Since 1 September 2003 new rules apply under the Pesticides Act 1999 that make training compulsory for people who use pesticides as part of their job. As of 1 September 2009 a new Regulation (NSW Pesticides Regulation 2009) was released, with increased penalties for improper record of pesticide use.

This includes

- herbicides (e.g. Roundup)
- insecticides
- fungicides
- bactericides
- baits
- lures
- rodenticides.

The ChemUse Card course has been developed to address the training needs of the horticulture industry, including Local Government staff. It conforms to the training requirements of the Pesticides Act. The content draws from the WorkCover Code of Practice "Safe Use of Pesticides including Herbicides in Non-Agricultural Workplaces".

This training is aligned to nationally-accredited Horticulture competency standards:

- RTC3704A (Prepare and apply chemicals)
- RTC3705 (Transport, handle and store chemicals)

These competencies are a partial completion of a Certificate III in Horticulture (RTF30103).

The topics covered in the training include:

- the control of weeds, pests and diseases
- determining, preparing, applying, storing and transporting chemicals
- directions, standards and legislative requirements
- hazards, risks and controls
- specific safety procedures for unsupervised pesticide application
- ensuring minimum risk to self, other, environment and non target organisms
- accurate record keeping

- who are required to store, handle, use and transport pesticides
- workers who are supervising others working with pesticides
- those who work in close proximity to where pesticides are stored and used
- Casual or seasonal workers who may use or come into contact with pesticides or hazardous residue

## **Baiting**

Participants that require this certification for the purpose of purchasing and laying baits such as 1080 are also catered for as the training fulfils the requirements of the Pesticide Control (1080 Liquid Concentrate and Bait Products) Order 2008.

## **Assessment Tasks**

To satisfy course requirements, participants are expected to complete written and practical assessment activities. Please let us know if there are any issues that your LGTI trainer should be aware of.

This may include;

- Literacy/numeracy issues
- Physical limitations, such as hearing, vision or mobility concerns
- Anything that may affect your experience in the training course

This course covers 2 nationally accredited units of competence in 1 day and it is an intensive day of training and assessment. If participants require additional or more specific information please contact us as we are happy to customise the *content* or the *duration* to suit the needs of you and your staff (In-house courses only).
